Dose 0.13-2.05 oz/gal (1-16 ml/L) of water. Wash temperature should be set at 122-140°F (50-60°C).

Ultrasonic:

Dose 0.13-2.05 oz/gal (1-16 ml/L) of water. Wash temperature should be set at 77-113°F (25-45°C). Discard solution according to facility policy. Do not mix with other chemicals. For professional use only.
