Store in a cool, dry place protected from frost and away from alkalis and strong oxidizing agents. Store upright in original containers. Recommended storage temperature 41-77°F (5–25°C).

Automatic Washing Equipment:

Dose 0.03-0.13 oz/gal (0.25-1.0 ml/l) in final rinse water. Temperature should be set at >122°F (>50°C).

Do not use on polycarbonate. Check polysulphone (PSU, PPSU) and similar materials for compatibility before use.

Do not mix with other chemicals.
